NOTIFICATION Sub: Renewal of Affiliation for the Academic Year 2019-20

Under the Karnataka State Universities Act, 2000 59th Case and under the provisions of 17 and the amended regulations of 2015, in exercising the said powers, the Bangalore Central University has renewed and approved affiliation of Visveswarapura College of Arts and Commerce, Bengaluru for the academic year 2019-20 for the below mentioned program/s under the following terms and conditions:

Note: A copy of the report of the Local Inquiry Committee for the year 2019-20 shall be submitted by email. Affiliation has been renewed in terms of intake prescribed by the University to the College. Compliance report and remediation activities taken up for shortcomings identified in the 'column numbered 0' in the Local Inquiry Committee report shall be submitted by the College, failing which the application for renewal of affiliation for the academic year 2020-21 shall not be accepted.

CONDITIONS:

- 1. The conditions imposed by the Local Inquiry Committee shall be complied with.
- 2. If the student intake exceeds the fixed number, approval will not be given for the excess admission.
- 3. No additional section shall be allowed without prior permission of the University
- 4. Orders relating to reservation issued by the Government from time to time shall be strictly adhered to while admitting students.
- 5. Every condition, rule, statute and order imposed by the University regarding the students, teaching and non-teaching staff shall be followed by the College. The number of students admitted to courses shall not exceed the intake fixed in the affiliation notification of the University and shall admit students as per eligibility rules made by the University for the courses.

- 6. For Post Graduate courses, admission of students should be made, and fees shall be collected as per orders issued by University from time to time. 50% quota (and 100% for government colleges) shall be filled by students sponsored by the University.
- 7. For post graduate courses, the College shall not admit students beyond the number specified by the University.
- 8. If any person (teaching/ non-teaching/ management) or student misbehaves or sexually harasses women/ girl students in the College, such an act shall be considered a punishable offence in accordance with the Order of the Supreme Court dated 13.08.1997 in Vishakha vs. Govt. of Rajasthan case and the admission of such student or appointment of such person who indulges in such activities shall be cancelled and action shall be taken in accordance with law. A committee to handle and restrict such offences/ activities shall be constituted, in accordance with the Order of the Supreme Court.
- 9. The College shall run certified courses for the development of the students. The Principal/Management shall treat the students/ teaching faculty with due courtesy.
- 10. The College Management shall not unnecessarily withhold the marks card or any other document of any student for a period of more than 6 months. Documents submitted shall be returned to the student expeditiously after admission approval by the University.
- 11. If any student applies for transfer certificate, the College shall not trouble the student while issuing the same. College shall not collect any amount other than the tuition fees for the remaining academic period.
- 12. Capitation fee shall not be collected by the College in any form.
- 13. Kannada language shall be used compulsorily in administrative matters.
- 14. Application for renewal of affiliation for the academic year 2019-20 shall be submitted by the College without fail.
- 15. Upon completion of 5 years, all colleges shall be subject to accreditation by NAAC.
- 16. The Principal shall submit the list of teachers eligible for valuation to Chairpersons of respective examination boards, failing which the affiliation shall be cancelled.
